Amongst other considerations, the seminar focuses primarily on planning, both at the macro and micro levels, highlighting its importance to establish strategy and devise tactics prior to moving forward and fully engaging internal audit's stakeholders. The seminar once again makes extensive use of practical examples to demonstrate how this can be realistically achieved and, perhaps more importantly, satisfactorily maintained over the longer term.

**Mr Francis Bugeja** is the Chief Audit Executive of the Central Bank of Malta, where he has pursued a varied professional career, occupying different positions in a number of business areas since he joined the bank in 1979. He is a qualified banker and a certified information systems auditor with over twenty-one years' experience, specifically, in internal auditing. He has been responsible for managing the Bank's internal audit activity since 2004 while for the past ten years he has been a member of the Internal Auditors Committee of the Eurosystem, the European System of Central Banks and the Single Supervisory Mechanism. He is also a member of the University of Malta's Audit and Risk Committee.
